- 10.2. As per the information and explanation given to me and the records verified by me, the Company does not have any specified unclaimed amount to be transferred to Investor Education and Protection Fund during the reporting period.
11. During the reporting period, the Audited Financial Statements of the company for the year ended 31<sup>st</sup> MARCH 2022 was approved and signed at



the meeting of the Board of Directors held on 24<sup>th</sup> May 2022. The report of the Board of Directors was approved at the meeting of the Board of Directors held on 24<sup>th</sup> May 2022 and it contains matters to be included therein as required under the provisions of section 134 of the Companies Act, 2013, applicable for the financial year ending on 31<sup>st</sup> March 2022.

The Company has sought and taken approval of the shareholders through Postal Ballot & Electronic Voting process on 26<sup>th</sup> December 2022 pursuant to 188(1)(f) of the Companies Act, 2013, and Rule 15(3)(b) of the Companies (Meetings of Board and Its Powers) Rules, 2014, and Regulation 17(6) and all other applicable regulations of the Securities & Exchange Board of India (Listing Obligations & Disclosure Requirements) Regulations, 2015, by passing special resolutions for payment of remuneration to two non-independent directors.



19.04. The Company has sought and taken approval of the shareholders through Postal Ballot & Electronic Voting process on 13<sup>th</sup> February 2023, by passing a special resolution to accord consent to Board of Directors to sell or dispose off landed property, pursuant to 180(1)(a) read along with section 110 of the Companies Act, 2013, and Rule 22(16)(i) of the Companies (Management & Administration) Rules, 2014.
